Founder & CEO

In our inaugural Annual General Meeting, I am delighted to share the remarkable journey of Villagehood Australia since its launch in 2020.

The escalating challenges of postnatal depression have underscored the urgency of our mission. The tragic increase in maternal suicide attempts and the loss of four lives in the West of Adelaide last year highlight the real impact on mothers, families, and communities.

In our community of 30,000 mothers with young children, around 3,000 women are battling postnatal depression and urgently need our support. While we have assisted over 1,500 women since 2020, our existing programs are at capacity, necessitating additional funding for expansion.

Villagehood Australia understands the hardships of motherhood, from self-doubt to guilt and loneliness. We believe in a better way, and since our launch, we've built a strong network of mothers, professionals, and volunteers. Despite the challenges posed by the Global Pandemic, we've not only endured but strengthened.

This year has been remarkable for Villagehood Australia, and we are proud of the positive impact we've made so far. As we gather for our first AGM, let's celebrate our achievements and look forward to expanding our reach.

Australia is a real village of peer and professional support for mothers and children

Villagehood Australia is a registered charity dedicated to empowering the community to help support the health & wellbeing of mothers, who are 95% of the time, the primary carers of children in the early years.

Over the past three years, we have built a strong support network that assists mothers to beat loneliness and isolation and build their capacity to better cope with the everyday challenges and invisible struggles of motherhood.

As a peer support organisation, we offer a safe place for mothers to come to and an alternative way to support their mental health. To participate women do not need of a doctor referral, there is no wait time and there is no stigma attached (women trust us because we get it and we don't judge).



Mums Programs

Evidence-based peer programs meeting the needs of the mothers.

At Villagehood Australia, we welcome every mother (and woman) into our village, holding space for her to maintain her sense of self, wellbeing and independence, as she navigates the trials and triumphs of motherhood.

Our programs are free and available to all mothers and their children, regardless of their life circumstances or social factors because we know that postnatal depression does not discriminate.

We offer a combination of programs that help improve the wellbeing of mothers and positively influence the children's development. Our evidence-based programs combine peer support and a group activity (moving, singing, creating, learning) to enable community connection, growth and alleviate the stigma around mental health to seek help early. The research shows that these programs can positively impact the health & wellbeing of mothers and children.

Based on lived experiences, conversations with mothers, and review of the research, we have recognised four motherhood stages in the early years (0-5 years). We provide four programs to meet the needs identified in each stage.

Our goal at Villagehood Australia is to build more resilient communities through a variety of events and training courses.

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result ofpast events, for which it is probable that an outflow of economic benefits will result and that outflowcan be reliably measured. Provisions are measured at the best estimate of the amounts required tosettle the obligation at the end of the reporting period.

Cash on Hand

Cash on hand includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

All revenue is stated net of the amount of goods and services tax.
